## **DIGITAL LEADER by Nwanneka Anakwe**

"On Tuesday, I was elected as one of the digital leaders for my school, Christ Church Primary School.

The people that wanted to be digital leaders signed up by producing a poster on social media and E safety. I was one of them.

Let me tell you all about it.

When you go online or using any digital device, always think about the SMART RULES.

You might ask, what are the rules?

#### S - means SAFE

Be careful when you are online or social media because people you don't know might ask you for your full name, address or personal information. DO NOT give these information out because it can be misused and it can lead to abduction, murder, abuse or other criminal activities.

#### M – means MEETING

Never agree to meeting someone you have only seen or spoken to online or on the phone. Never agree to meeting any such contact without permission from one of your 5 trusted adults.



#### A - means ACCEPTING

This is accepting information that strangers tell you or accepting messages that pop up online, on your phone, on instagram, TikTok etc.

This is because it can contain unkind messages, nasty computer viruses, scams and hacking software by cyber criminals and bullies.

#### **R - RELIABLE**

This means social media might not be as reliable as you think it is. People might be lying about who they are, what their job is and what they look like. In other words, they can impersonate or mimic both younger and older people or even family members.

#### T - TELL

Tell one of your 5 trusted adults if something online makes you uncomfortable. Don't forget to STOP, CLOSE and TELL.

So, there you are, the SMART RULES!

Do not be scare or afraid to use online, social media or digital device, but ALWAYS be SMART and vigilant.

As a digital leader of my school, I take digital safety very seriously.

Next week, all the digital leaders are having a meeting on how to use our MINE CRAFT lessons.

If I'm allowed, I would also like to be one of the digital leaders for our church.

#### Peace in the Middle East

The Very Revd Canon Richard Sewell, Dean of St George's College and Dean of the Cathedral, Jerusalem, has been in the UK for a while talking about the situation that exists there. He is now returning to the College and Cathedral, its congregation and community. In his farewell message he said, "With thanks to all those who expressed such love and concern and those who prayed for a safe return. We were finally reunited in Jerusalem to face together whatever lies ahead. The fellowship of the community of the Cathedral Close, our family, friends locally and abroad and our faith in the redeeming and reconciling love of God gives us strength and courage. Along with so many others from every community we pray for an end to this dreadful war, for the establishment of justice and for the long work of peace and reconciliation to begin". #### NIGHT SHELTER PROJECT – 29 OCTOBER – 10 DECEMBER

The Night Shelter project starts on Tuesday 29 October and every Tuesday until 10 December. As many of you will be aware we run this project at our church in partnership with Alyth Synagogue every year. The



project is overseen by Homeless Action in Barnet (HAB). Homeless people(guests) register with HAB to be provided shelter overnight over the winter months. Churches and synagogues partner to offer a day when the homeless can sleep overnight on their premises. Each person who registers is provided with bedding which is transported to the next venue after the guests have had breakfast and left for the day.

## How can you help?

Each year we appreciate help from people who are willing to make food – either a first course, a main course or a pudding. At the start there are only a handful of guests but as the weeks progress this number can go up to 14-15. Alyth always have enough volunteers to make the food. Our church provides the venue. It would be helpful to see people putting their names down to come in the evening to serve the food, talk to the guests and help clear up after supper or to help with breakfast on the Wednesday morning.

Those of us who have helped in the past have really enjoyed it. You will only need to put your name down for a couple of times over the period of the project. We also serve breakfast so if people can do an early shift before going to work – that will be great. Daniel has helped to transfer the bags for the last couple of years. Someone with a car able to carry 4-5 bags will be most welcome to join in.

We do need some young people to sleep over during the night – usually two people. I know Dozi has done it in the past, but it will be really wonderful if a couple of other people are able to join him. Again it has only to be a couple of times over the term of the project.

I will put a rota send by Alyth in our WhatApp – please look at it and see if you are able to give some time to this worthwhile project – it is our way of sharing God's love practically. Please feel free to contact me or talk to me if you have any questions or want to be involved this year!

#### **APPENDIX 1**

## Golders Green Parish Church Photography policy -Approved by the PCC

Golders Green Parish Church (GGPC) is committed to the highest possible levels of safeguarding policy and practices, including child protection. As part of that commitment, we have agreed this policy relating to the taking and use of photographs and films in our church building and at church events. The same issues apply to still photographs, digital images and films and personal information held by the church.

Images of children, adult members of our church and others who come to the building have become an important and much-appreciated part of the way we at GGPC record and celebrate what we do at church. That can include, for instance, our worship, events after services such as our bring and share lunches, birthdays and other celebrations, toddler group and other weekday gatherings. All of these, and other events, help us develop our sense of community.

The images are very often included in the newsletter, and may also appear as hard copies on a noticeboard, or digitally on our website, in our church WhatsApp group or in social media. They may be taken by an appointed church member or employee, or by a professional photographer or visitor. We are, however, conscious that in today's world this cannot be risk-free. This is why we have produced this policy, which is in line with Church of England guidelines.

# With our commitment to the highest standards of safeguarding in mind, and in order to comply with data protection legislation, GGPC has committed to the following principles:

The taking and use of images must be: o Respectful o Not intrusive o Appropriate and relevant o On the basis of informed consent, and on the understanding that there is no pressure to consent

All images will be stored securely and deleted when they are no longer needed. We will keep all written consents or refusals of consent, which will include names and contact details, on a secure database.

If consent is given it may be withdrawn at any time and no reason need be given. Images count as sensitive personal data under the Data Protection Act 2018 and the General Data Protection Regulations (GDPR). As with all such data, they should only be used with the consent of the person in the image. 2 The obtaining of informed consent is vital.

While the basic principles set out above must be complied with in relation to all images whether of adults or children, there are some differences in practice which need to be observed. If we wish to take images of people with care and support needs there are additional issues to consider:

- Adults must be able to consent to their image being used;
- Legally, the only person who can offer consent for the use of their image is the adult themselves. Family members such as adult children, parents, spouses or siblings and support workers/ personal assistants should not be approached to sign consent forms for adults;
- Information about how the images will be used should be provided to an adult in an accessible format, using for example, easy-to-read language or pictures;
- If we have any concerns that an adult does not have the capacity to give consent to photography or filming, or to understand that photographs or films are being taken during an activity, we will discuss this with them, including if appropriate any support person or personal assistant for the adult;
- If after this conversation we feel that the adult still cannot give consent then we will not use their image.

#### When a child is the main subject or could be recognised we will

- Where the child is under 13, seek consent from their parent but involve the child as well
- Where the child is between 13 and 16, seek consent from the child and the parents



• Where the child is 17, seek consent from the child. If the child consents we will inform their parents that they have agreed to the use of their image Form of consent.

So that we can appropriately seek and record the giving or refusal of consent to the taking and use of images, we have prepared letters addressed respectively to adults and parents/carers, which are found in the annexes to this policy. This policy will be regularly reviewed by the PCC to ensure it remains fit for purpose.

- We will keep your written consent or refusal of consent, which will include your name and contact details, on a secure database. If you give your consent you are entitled to withdraw it at any time.

The church is committed to processing information in accordance with the General Data Protection Regulation (GDPR). The personal data collected on this form will be held securely and will only be used for administrative purposes.

**Your rights**: You have the right to request to see a copy of the information we hold about you and to request corrections or deletions of the information that is no longer required. You can ask the church to stop using your images at any time, in which case it will not be used in future publications but may continue to appear in publications already in circulation.
